Key Messages for the House and Senate:

- The COVID-19 pandemic has put the healthcare workforce in crisis, and safety is suffering.
- NPSB's data-driven solutions would prevent harm before it occurs and reduce the burden on frontline teams.
- A growing coalition of leading healthcare organizations and experts is on board.
- Now is the time for Congress to establish the NPSB.

What is the problem of medical error in the U.S.?

- Prior to COVID-19, medical error was widespread.
 - A recent Office of the Inspector General report saying 25% of hospitalized Medicare patients experienced harm and 43% of the harm was preventable.
- Recent reports from leading U.S. healthcare agencies indicate patient safety has gotten dramatically worse since the start of the pandemic.
 - The Centers for Disease Control and Prevention and Centers for Medicare and Medicaid Services have seen a 28% increase in central line infections and a 17% increase in falls and 42% increase in pressure ulcers in skilled nursing facilities.
- There is no centralized agency to ensure the sharing of solutions to support patient safety.

What is the NPSB?

- The NPSB is a proposed independent, nonpunitive federal agency, modeled after the transportation industry.
- The NPSB will conduct centralized studies into widespread harms, and it will recommend solutions to improve patient safety by addressing precursors to harm using autonomous solutions.
- The NPSB will support existing agencies in monitoring and anticipating harm using existing data sources.

Why is this needed now?

- U.S. Representative Nanette Barragán (D-CA) introduced the bill "**H.R.9377 - the National Patient Safety Board Act,**" legislation to establish an independent federal agency dedicated to preventing and reducing healthcare-related harms. We are seeking additional cosponsors in the U.S. House.

- The healthcare workforce is in crisis, healthcare safety is suffering, and we need a federal agency solely focused on creating and sharing solutions to stop preventable harms. An NPSB will use interdisciplinary thinking through public-private partnerships teams and innovative technology to detect and stop widespread harms before they happen.
