



# National Patient Safety Board Advocacy Coalition Communication Tips

House Bill Reintroduction, 2024

As a member of the National Patient Safety Board (NPSB) Advocacy Coalition, your support for the NPSB legislation is critical. The following tips can help you shape your messaging when discussing the NPSB legislation with colleagues, the media, and other stakeholders.

- **When discussing NPSB:** Highlight the problem of medical error and the impact that the workforce crisis is having on patient safety.
  - Medical errors were already widespread before the pandemic
  - Patient safety has worsened over the past three years
  - Workforce strains and burnout are worsening patient safety
- Emphasize that the NPSB will use existing data sources to identify patterns and precursors to harm to ensure no additional burden or data entry on the workforce.
- Stress that the NPSB will complement the work of the many federal agencies already involved in various aspects of patient safety and that no government entity is tasked with looking at patient safety nationwide; NPSB would fill this gap.
- Describe the NPSB as being prevention-focused through its use of a public-private partnership team to develop solutions to prevent injuries and harm
- Discuss the potential for advanced analytics, AI, and ML to alleviate the burden on the already-strained healthcare workforce while dramatically increasing safety for patients and providers. The NPSB will also utilize the expertise of human factor engineers to take the burden off the healthcare workforce.
- Describe the NPSB Advocacy Coalition as a coalition of more than 90 healthcare organizations, provider associations, businesses, nonprofit organizations, and consumer advocacy groups committed to federal action on patient safety who have reached consensus around this solution

## **Avoid the following:**

- Language such as “investigation,” “oversight,” “regulation,” or “enforcement” when discussing the actions of the NPSB
- Referring to the NPSB as an independent “agency”
- Stating or implying that the NPSB will require “reporting”
